

Joshua Price-Brent (Defendant) told officers, at the scene, that he was operating the Mercedes and crashed it. Passenger Jerry Brown Junior was killed in the crash. Officers at the scene determined that the Defendant was intoxicated, he crashed the Mercedes due to his intoxication and arrested him for Intoxication Manslaughter Texas Penal Code number 49.07 (Felony-2) Irving Police Report number 12-28613. The Mercedes was seized from the roadway as evidence and towed to the Irving Police Auto Pound. In or on the Mercedes are the items listed in number 2 that will aid the Affiant in this investigation.

Wherefore, Affiant asks for issuance of a warrant that will authorize him to search said suspected place and premises for said property and seize the same and to arrest each said described and accused person.

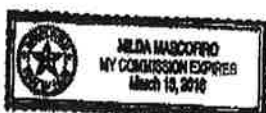


